Employment

Lifeworks supported hundreds of individuals with disabilities in finding and maintaining competitive jobs in the community. This included 198 new job placements and 82 new employer partners, bringing the total number of individuals supported on the job to 603 and the total number of employer partners to 306.

On March 1, 2017, Lifeworks chose to become one of just a handful of disability service providers statewide without a special wage certificate, meaning that all individuals supported on the job earn at least minimum wage. The average wage of a Lifeworks associate directly hired by a business was \$11.02.

Fiscal Support

Lifeworks supported more than 1,900 individuals to self-direct the services they receive. As an approved fiscal support entity through the state of Minnesota, Lifeworks helped individuals enrolled in the Consumer Directed Community Supports (CDCS) and Consumer Support Grant (CSG) programs. Lifeworks also served as a knowledgeable PCA Choice provider agency and a licensed provider of Personal Support.

The individuals supported by Lifeworks selected, hired, and trained more than 4,000 employees to provide the assistance they need to live in their homes and access the community. In 2017, 200 new individuals

A draft of the Financial Audit and Form 990 are presented each year to the Audit & Investment Committee for review. Upon review, the Audit & Investment Committee presents the meeting minutes, the Financial Audit and Form 990 to the full Board for approval.

Disclosure in the organization should be made to the President and CEO (or if she or he is the one with the conflict, then to the Chair of the Audit and Investment Committee), who shall bring the matter to the attention of the Audit and Investment Committee. Disclosure involving directors should be made to the Chair of the Audit and Investment Committee, (or if she or he is the one with the conflict, then to the Chair of the board) who shall bring these matters to the Audit and Investment Committee. In each case, the Audit and Investment Committee shall review the possible conflict and report it to the board along with a recommendation for resolution.

The board shall determine whether a conflict exists and in the case of an existing conflict, whether the contemplated transaction may be authorized as just, fair, and reasonable to Lifeworks. The decision of the board on these matters will rest in the sole discretion of Board of Directors, and their concern must be the welfare of Lifeworks and the advancement of its purpose.

When making the recommendation, the committee relies on comparability data provided by internal HR staff and, from time to time, outside consultants.

In January of 2017, Lifeworks hired a new President and CEO. That search

process was conducted during the second half of 2016 by the external firm of LymanDoran. During that recruitment effort LymanDoran captured significant competitive compensation information on the candidates they sourced. Full compensation histories of the finalists were reviewed by the Board's Search Committee that included all members of the Compensation Committee. That data was used to develop a compensation package approved by the full Board.

Annually, human resources reviews the pay structure for the Vice President of Finance position using salary surveys that compare the position to similar positions in other for-profit and nonprofit organizations in Minnesota and then reviews it with the President & CEO who then decides the Vice President of Finance's compensation.
