We had 483 volunteers who gave 6,953 hours of service to support increased community inclusion opportunities, career counseling and mentoring, and leading meaningful activities such as book club and art.

Community Employment

Lifeworks supports individuals with disabilities to find and retain employment and to advance in their career of choice. In 2016 Lifeworks served 863 individuals including 121 new employment placements. Our

recommending performance objectives for the CEO, evaluating the CEO's performance, and recommending to the board the base salary, cash incentive bonus, and other compensation for the CEO of Lifeworks. When making the recommendation, the committee relies on comparability data provided by internal HR staff and, from time to time, outside consultants.

In 2016, the committee based their recommendation from two sources; a customized survey sponsored by MRA that benchmarked CEO compensation of similar size organizations in the human services industry within Minnesota and the 2015 National Executive Compensation Survey that included 39 non-profit CEOs across the country that led organizations with revenues between \$25M - \$99M. The committee presented their recommendation to the board where the compensation amount was approved.

Annually, human resources reviews the pay structure for the Vice President of Finance position using salary surveys that compare the position to similar positions in other for-profit and nonprofit organizations in Minnesota and then reviews it with the President & CEO who then decides the Vice President of Finance's compensation.
