Refuse to supply some or all information we request.	You may refuse to supply some or all of the information we request, but if you refuse to provide necessary information, you may not qualify for services, or we may be unable to provide services to you.

We may charge a reasonable, cost-based fee, however, we will not charge a fee if you ask for a copy of your record to review your current care.</li> </ul>
Ask us to correct your medical record	<ul> <li>You can request to amend health information about you that you think is incorrect or incomplete by submitting a written request to our Compliance Department at the address listed above.</li> <li>We may say "no" to your request to amend, but we will tell you why in writing within 60 days.</li> </ul>
Request confidential communications	<ul> <li>You can ask us to contact you in a specific way (for example, home or office phone) or to send mail to a different address.</li> <li>We will say "yes" to all reasonable requests.</li> </ul>
Ask us to limit what we use or share	<ul> <li>You can ask us <b>not</b> to use or share certain health information for treatment, payment, or our operations. We are not required to agree to your request, and we may say "no" if it would affect your care.</li> <li>If you pay for a service or health care item out-of-pocket in full, you can ask us not to share that information for the purpose of payment or our operations with your health insurer. We will say "yes" unless a law requires us to share that information.</li> </ul>
Get a list of those with whom we've shared information	You can ask for a list (accounting) of the times we have shared your health information for six years prior to the date you ask, who we shared it with, and why. We will include all the disclosures except for those about treatment, payment, health care operations, and certain other disclosures (such as any you asked us to make). We will provide one accounting a year for free but will charge a reasonable, cost-based fee if you ask for another one within 12 months.



Get a copy of this privacy notice	You can ask for a paper copy of this notice at any time, even if you have agreed to receive the notice electronically. We will provide you with a paper copy promptly.
Choose someone to act for you	<ul> <li>If you have given someone medical power of attorney or if someone is your legal guardian, that person can exercise your rights and make choices about your health information.</li> <li>We will make sure the person has this authority and can act for you</li> </ul>
	before we take any action
File a complaint if you feel your rights are violated	You can complain if you feel we have violated your rights by contacting the Lifeworks Compliance Department at the address and phone number listed above.

Lifeworks Uses and Disclosures	How do we typically use or share your health information?  We typically use or share your health information in the following ways.	
Serve You	We may use your health information to determine if you meet Lifeworks' admission criteria, and to provide services to you.	• <b>Example:</b> Your information is used to determine which service or support is suited to your needs and goals.
Collaborate with Others Who Serve You	<ul> <li>We may use your health information to plan and coordinate transportation.</li> <li>We may share your health information with service providers who are serving you.</li> </ul>	Example: Your address is provided to the transportation provider so you can receive rides to and from Lifeworks.
Run our organization	We may use and share your health information to run our business, improve your care, and contact you when necessary	Example: We use health information about you to conduct quality assessment and improvement activities
Obtain payment for your services	We can use and share your health information to obtain payment from health plans or other entities	Example: We give information about you to your health insurance plan or to the State of Minnesota so it will pay for your services
Share with government agencies as appropriate	We may share your information with governmental entities who fund and oversee the services we provide	Example: We give information about you to the Minnesota Department of Human Services



How else can we use or share your health information? We are allowed or required to share your information in other ways – usually in ways that contribute to the public good, such as public health and research. We have to meet many conditions in the law before we can share your information for these purposes. Help with public health and safety issues	<ul> <li>We can share health information about you for certain situations such as:</li> <li>Preventing diseases</li> <li>Reporting adverse reactions to medications</li> <li>Reporting suspected abuse, neglect, or domestic violence</li> <li>Preventing or reducing a serious threat to anyone's health or safety</li> </ul>
Do research	<ul> <li>We can use or share your information for health research, but we will only share your information with an external researcher if you provide us your written consent to do so.</li> </ul>
Comply with the law	<ul> <li>We will share information about you if state or federal laws require it, including with the U.S. Department of Health and Human Services and the Minnesota Department of Human Services if either wants to see that we're complying with federal or state privacy law.</li> </ul>
Work with a medical examiner or funeral director	<ul> <li>We can share your health information with a coroner, medical examiner, or funeral director if and when you die.</li> </ul>
Address workers' compensation, law enforcement, and other government requests:	<ul> <li>We can use or share health information about you:         <ul> <li>For workers' compensation claims</li> <li>For law enforcement purposes or with a law enforcement official</li> <li>With health oversight agencies for activities authorized by law</li> <li>For special government functions such as military, national security, and presidential protective services</li> </ul> </li> </ul>
Respond to lawsuits and legal actions	<ul> <li>We can share health information about you in response to a court or administrative order, or in response to a subpoena</li> </ul>



## **Our Responsibilities:**

- We are required by law [including the federal Health Insurance Portability and Accountability Act, as amended by the Health Information Technology for Economic and Clinical Health Act (collectively called "HIPAA"), the Minnesota Government Data Practices Act (MGDPA), and other state and federal laws, rules, and regulations] to maintain the privacy and security of your protected health information.
- We will let you know promptly to the extent required by law at the address we have on file for you if a breach occurs that may have compromised the privacy or security of your information.
- We must follow the duties and privacy practices described in this notice and give you a copy of it.
- We will not use or share your information other than as described here unless you tell us we can in writing. If you tell us we can use or share your information in a certain way, you may change your mind at any time and we will not do it in the future. Let us know in writing if you change your mind.
