Lifeworks Services, Inc. will conduct a charitable raffle on May 9, 2025, to raise funds for our core services and innovative initiatives on behalf of those we serve.

In compliance with city and state laws, Lifeworks Services, Inc. has set forth the following house rules for this raffle:

1. Raffles are a form of gambling. If you or someone you know has a problem with gambling addiction, call the toll-free problem gambling helpline at 1-800-333-HOPE.
2. Raffle tickets will be sold from April 18, 2025, to May 9, 2025.
3. Individuals may purchase one or more raffle tickets. Only one ticket is required to enter the raffle.
4. The price is \$60.00 per ticket. Debit card purchases will be charged a processing fee of 4.5% of ticket price. No discounts or donations of tickets are allowed according to state law. Tickets are non-refundable.
5. Individuals may purchase tickets using cash, checks, or debit cards from Lifeworks Services and Event Staff at the Annual Celebration on May 9. Credit cards may not be used to purchase raffle tickets according to state law. Payment must be issued before individuals can receive a raffle ticket.
6. Tickets must be purchased in-person according to state law. No phone or online payments are allowed. Individuals may purchase raffle tickets with cash or check from Lifeworks Services staff in advance of the Annual Celebration by contacting giving@lifeworks.org to coordinate purchase and payment drop off at Lifeworks' office (6636 Cedar Avenue S. Suite 250, Richfield, MN 55423). Tickets purchased in advance can be held for pick-up at the Annual Celebration, picked up from our Richfield office, or

Lifeworks staff can fill out the stub and email you the ticket number, according to your preference.

7. Individuals must provide their name, phone number, and address on the raffle ticket for the ticket to be valid.
8. Individuals must be 18 or older to purchase a raffle ticket or to win a prize.
9. Raffle managers are not allowed to purchase tickets or win a prize. Other Lifeworks staff, board members, or persons not involved in managing the raffle may purchase tickets and win prizes.
10. The raffle drawing will be held during our 2025 Annual Celebration on May 9 at the Hilton Minneapolis Hotel (1001 S. Marquette Avenue, Minneapolis, MN 55403). Raffle ticket holders need not be present to win.
11. Raffle winner will be selected by ticket drawing. All entries will have an equal chance to win. One winner will be selected. Winner of the raffle can choose between four options for the vacation price.
